This week in the Nursery we have been learning a poem all about Spring. We went into our garden to look for signs of Spring, new flowers, buds on our apple tree and a bumble bee. The children have also been busy planting our seed potatoes from the Grow Your Own Potatoes growing project and writing their names for their Easter card.



This week our reception children have been getting ready for the Easter celebrations. They have been learning about what Easter means to Christians during their RE lessons and this week Reverend Chris visited to talk further about the meaning behind the Easter celebrations. It is great for the children to hear first-hand about the celebrations that will be taking place in our local churches.

The children have also been enjoying some mini egg maths in small groups. They have opened a bag of mini eggs and used the eggs to practise their subitising skill to find out how many eggs there are. They sorted the eggs and used them to develop their early addition skills. They really enjoyed eating them afterwards!

Spring has also sprung in the reception outside area where children have been hard at work planting onions, potatoes and herbs. The children are excited to see what happens to these over the next few months.



This week in Geevor, we have been using the parachute as part of our healthy movers' time. The children have loved shaking the parachute to see how quickly they can shake off the foam balls!



This week in English we have been writing our own mixed up Fairy Tales and practising using conjunctions.

We have also been using the iPads to navigate mazes using algorithms. Some of them needed a little bit of debugging before they worked perfectly.

Year 1 have also been learning to make equal groups ahead of their multiplication work after Easter.



Year 2 have been exploring their understanding of resurrection this week linked to the Christian story of Easter. We used drama to retell the story, reflected upon why we thought Easter was Important to them and made an Easter Card in Cornish. Pass Lowen onan hag oll!



This week was the last session for our Year 1's First Lego League Club. This year's theme was 'Masterpiece'. The pupils have been learning about museums, concerts, theatres and performance venues. They have been thinking about what they need to run these events e.g. seating, ticket offices, lights, staging etc. During our final session groups presented their projects to some familiar VIPs. Mrs Callow and Mrs Montgomery-Smith were impressed by all their masterpieces and how well they spoke about the projects.

### **Poppy Playtime**

It is important that you are aware that whilst the name and characters suggest a playful game, it is a survival horror game with graphics that may not be suitable for your child. It includes characters such as 'Kissy Wissy' and 'Huggy Wuggy,' Please view this game before allowing your child to play it as it may not be appropriate for them – particularly young children.

Children may be playing the game or just watching videos of it on sites such as YouTube or playing replicated versions on Roblox for example.

Some platforms will allow you to set who can contact your child as well as switch off communication so ensure appropriate settings are explored and set up. ### Cyberbullying

#### What is cyberbullying? Cyberbullying is bullying

online and can take many forms such as sending malicious messages, leaving nasty comments, excluding somebody from a group chat, blackmailing or setting up a fake profile. Cyberbullving can



take place across many different platforms such as WhatsApp, Snapchat and on games such as Roblox and Minecraft.

#### What should I do if my child is being bullied online?

If your child is being bullied, then try to stay calm and let them know that it is not their fault. It is always useful to keep evidence of any online bullying and inform their school so that they are aware. Show your child how to block and/or report any users/content and review their privacy settings to limit what others can see. You may also wish to set up any parental controls that are available.

#### **Group Chats**

Group Chats are available on various messaging apps, social media apps and in some games. When your child is part of these groups, they may not know all the other members and it may even include people that they have previously blocked. Your child may come across inappropriate content and bullying can take place within these groups. Talk to your child about how they speak to others online and encourage them to talk to people online with kindness, like they would if they were face-to-face. ### TikTok

You must be over 13 years of age to use TikTok.

TikTok is a social media platform for sharing and watching short video clips. Some of the videos may not be appropriate for your child to view and there is also the risk of strangers contacting your child. If your child is using TikTok then make sure appropriate security/privacy settings are applied.

#### Account set up

As always, it is important that when setting up an account, your child enters their real date of birth as accounts are tailored by age e.g., direct Messaging is disabled for accounts aged 13-15. In addition, advertisements are tailored to their age. By default, accounts for people under 16 are set to private and we would recommend keeping it as this. This means your child must approve follower requests. #### Family Pairing

This allows you to link your own account to your child's account. You can then set controls such as restricted mode. You can find out more here: <a href="https://www.tiktok.com/safety/en/guardians-guide/">https://www.tiktok.com/safety/en/guardians-guide/</a>

#### Inappropriate content, themes and challenges on TikTok

Whilst against TikTok's guidelines, explicit and inappropriate content can be found on this platform, for example nudity/sexual content and hate speech. We often see viral challenges on social media, some of which can be dangerous. If your child is using TikTok, chat to them regularly about what they are viewing.

#### **Trends and Influencers**

We often see trends on social media, for example a latest trend found is around skin care routines, which can lead to children purchasing products that are completely unsuitable/dangerous for their skin. Influencers are people who have a large following on social media who through recommendations and promotions, influence the behavior or buying habits of others. #### Stranger contact

Talk to your child about who is following them online and ensure that they understand that people may not be who they say they are when online. It is important that children know not to share personal information.

#### **Blocking and Reporting**

Ensure your child knows how to use the safety features available to them, including how to report comments, direct messages and another user.

### **Online Challenges**

Our children may not have developed the skills and ability to critically analyse all situations yet so it is important to talk to your child about hoaxes and challenges that may appear on the internet. Some challenges are fun and provide no risk, however there will be challenges that are risky/dangerous. Just recently, a child sadly died after participating in a challenge - more information here: https://ineqe.com/2024/03/19/danger ous-challenge-safeguarding-risks/

Your child may see others complete certain challenges online without being harmed and therefore may want to repeat them and not consider the potential risks to themselves. Make sure they know that they should talk to you (or another trusted adult) about what they see online, particularly if they plan to try a challenge.

We would always advise that if your child has not heard about an online challenge, then do not draw attention to it as this may lead to them searching for it out of curiosity, so just talk about challenges in a general sense. Furthermore, reassure your child that challenges that suggest that terrible things will happen if they do not complete the tasks are not real.
